PANDEMIC UNEMPLOYMENT ASSISTANCE UNEMPLOYMENT BENEFITS FOR "GIG" WORKERS, FREELANCERS AND THE SELF-EMPLOYED

If you are out of work or had your hours reduced because of the COVID-19 pandemic, you may be eligible to receive unemployment benefits from the new federal Pandemic Unemployment Assistance (PUA) program. This benefit is for gig workers, freelancers, the self-employed, business owners, individuals with limited work history and others not usually eligible for regular Unemployment Insurance (UI) benefits. The assistance is distributed by California's Employment Development Department (EDD) and is available to all eligible CA residents who have authorization to work in the U.S.

APPLY NOW

Not sure if you are eligible? Apply anyway as soon as you are out of work. EDD will review your application and will confirm eligibility and what to expect next.

Note: If you are already receiving UI benefits, you cannot qualify for PUA benefits.

)WEEKLY **Benefit** Amounts

Regardless of when you submit your application, PUA benefits are retroactive as far back as Feb. 2, 2020, depending on your last day of work due to COVID-19. PUA payments are issued in phases:

PHASE 1

\$167 per week for each week you were unemployed from Feb. 2 to March 28, 2020.

PHASE 2

\$167 plus \$600 per week for each week you were unemployed from March 29 to July 25, 2020.

PHASE 3

\$167 per week for each week from July 26 to Dec. 26, 2020, up to a total of 39 weeks (minus any weeks of regular UI and certain extended UI benefits that you may have received).
